Dear Friends,

On behalf of Trilogy and our Board of Directors, we are pleased to present our FY 21 Annual Report. Last year was a year of growth, reinvention, and celebration. We were proud to celebrate Trilogy's 50th anniversary, and took the opportunity to renew our commitment to our work and reflect on the ways in which Trilogy has grown, evolved, and adapted over the last half century.

It was also a year in which we met immense challenges with resilience and determination. As the COVID-19 pandemic surged through our community, we continued to provide a full array of services while keeping our clients and employees safe. We collaborated with our partners at Heartland Health and Genoa Healthcare to ensure that COVID-19 vaccines and boosters were readily available and equitably distributed. As the pandemic began to recede, we were able to re-open the Beacon drop-in center for our most vulnerable clients. We also celebrated the return of our annual client Thanksgiving celebration, a cherished Trilogy tradition, in an outdoor format that allowed us to share the spirit of gratitude.

We also continued to identify and address the most pressing needs of the people and the communities we serve. We opened Ogden Apartments, a supported independent living community for people transitioning from homelessness or out of long-term nursing facilities. And we heard the increased calls for alternatives to 911 for those experiencing mental health crises and launched our First-response Alternative Crisis Team (FACT), which dispatches mental health professionals to address these crises.

Finally, we realize that Trilogy's commitment to accessible integrated mental healthcare means that we need to continue to invest in historically under-resourced areas. We are excited to announce that Trilogy is planning to create a service hub in the Chatham neighborhood on Chicago's South Side. While Trilogy currently serves residents regardless of their ZIP code in multiple locations city-wide, we plan to create an integrated behavioral healthcare campus on the South Side that will provide the same depth of services as Trilogy's main facility in Rogers Park.

We are honored and humbled to continue serving the clients and families who rely on us, and we are incredibly grateful to our supporters who make it possible for Trilogy to improve the lives of our clients every day.

#### BARRIER:

Lack of permanent, supported housing on the South Side

#### TRILOGY IS A PART OF THE SOLUTION: Trilogy's Ogden Apartments

Overlooking Ogden Park's 60+ acres of recreational greenspace, Ogden Apartments is Trilogy's newly-rehabbed dwelling for people in urgent need of housing. Opened in fall 2021 in collaboration with Interfaith Housing Development Corporation, Ogden Apartments provides 25 new units of permanent supported housing for people who were previously experiencing homelessness, as well as people who transitioned from long-term care facilities like nursing homes.

More than a safe place to live, Ogden Apartments provides a comprehensive array of wrap-around supports, including on-site counseling and around-the-clock staffing in a secure environment. The location is close to essentials like transit, groceries, a pharmacy, health services, banking, and more.



Joel and Victor were the first residents of Ogden Apartments. Both men slept on public transportation the night before moving in. Stable housing will play a key role in their personal recovery and mental wellness goals.

## Highlights from the last year:

#### BARRIER:

Lack of alternatives to 911 for mental health crises

#### TRILOGY IS A PART OF THE SOLUTION: First-response Alternative Crisis Team (FACT)

In recent months, the need for appropriate responses to mental health emergencies has become increasingly clear. The COVID-19 pandemic exposed significant disparities in our healthcare systems and led to a surge of deaths by drug overdose and suicide. In addition, disproportionate harms experienced by Black and Brown communities because of police interactions have underscored the need for alternatives to 911 for people experiencing mental health crisis.

#### The First-response Alternative Crisis Team

**(FACT),** Trilogy's new mobile crisis intervention and response unit, is addressing this need.

Using the model of crisis response outlined by the Substance Abuse and Mental Health Services Administration (SAMHSA), Trilogy clinicians are responding in pairs to mental health emergencies in Chicago's Rogers Park, Edgewater, West Ridge, and Uptown neighborhoods, as well as Evanston and Skokie.

This commitment also means that Trilogy will be working to increase access to integrated mental healthcare services across Chicago, with a focus on historically under-resourced areas.

Trilogy is excited to announce that we are opening a service hub in the Chatham neighborhood on Chicago's South Side. It is our intention to grow this new location to eventually mirror the capacity and services of our Rogers Park location in the years ahead.





## **About Our Clients**

Trilogy serves people of all races, backgrounds, and identities. Often, our clients have complex needs and many face multiple barriers to stability. The experiences of each client are unique, and we customize our services to meet their individual needs. Last year:

Trilogy served **3,653** clients and the need for services is increasing. Employees completed **887** client intakes. Of those intakes, **725** were new clients.

There were 242,795 client encounters and 162,912 hours of direct client service.

On average, clients had TO encounters per month with Trilogy ensuring they received the support they need.

The average length of a client encounter was **40** minutes.

Trilogy adapted by providing **85,611** encounters via telehealth services.

Trilogy transitioned **114** people to permanent housing in FY 21.




Many of Trilogy's clients experience homelessness or chronic housing instability.

## **24%** of clients are experiencing homelessness at intake.

Many Trilogy clients have experienced traumas that increase the risk of poor health outcomes later in life. In fact, **46%** have an Adverse Childhood Experiences (ACES) score of **4** or higher, a number that correlates to elevated risk for mental illness, chronic health problems, and substance misuse in adulthood.

80% of clients have a physical health condition (such as hypertension, diabetes, or asthma).30% have co-occurring substance use disorders.
